SPECIFIC AGREEMENT OF COLLABORATION BETWEEN THE AUTONOMOUS UNIVERSITY OF THE STATE OF HIDALGO, HEREINAFTER BE CALLED “THE UAEH” AND WHO SHALL BE REPRESENTED BY ITS RECTOR, HUMBERTO AUGUSTO VERAS GODOY AND ASSISTED BY THE SECRETARY GENERAL MTRO. ADOLFO PONTIGO LOYOLA, AND THE JEJU NATIONAL UNIVERSITY WHO WILL HEREINAFTER BE CALLED “JEJU NU” REPRESENTED BY HYANG JIN HUH, IN HIS CAPACITY AS PRESIDENT IN ACCORDANCE WITH THE FOLLOWING STATEMENTS AND TERMS:

OBJECTIVE

The present Agreement aims to establish a student exchange program from different academic areas with the objective of providing participating students the opportunity of taking an academic term abroad.

COMMITMENTS FROM BOTH PARTIES

For the correct operation of this Agreement, the signing parties commit themselves to:

C L A U S E S

FIRST. – Both institutions agree to admit 8 incoming exchange students that have completed at least a third part of their academic program in their home university.

SECOND. – Students must matriculate themselves in their home institutions as regular students.

THIRD. – The host institution will not charge the incoming exchange student any kind of fee.

FOURTH. – All of the expenses related to transportation, accommodation, food, medical insurance and of any other kind are the sole responsibilities of the exchange student.

FIFTH. – The exchange student will be provided with access to library and network services and to sporting facilities at the host institution.

SIXTH.- The selection process of exchange students is the home institution's responsibility. According to this, the home university must inform the host one, with at least three months before the beginning of the academic term, the names of the selected students.

SEVENTH. – The subjects and/or credits that the student passes and/or obtains will be recognized and validated by the home institution.

EIGHTH. – For the correct implementation of the program, the executing units identify themselves as follows:



On behalf Dr. Young Hoon Kang, Dean of the International Affairs Office, and Mr. Rafael Cravioto Torres, Director of the Office of International Relations.

NINTH. – This protocol will have a validity of 5 five years, after which the experience will be evaluated and thus this agreement can be renewed if both parties consider it to be necessary.

TENTH.- This agreement can be terminated by initiative of any of the parties. However, the termination initiative should be submitted by written means with at least 90 (ninety) days prior to the termination date. In the event that there were activities still being performed and not yet concluded, they will not be affected in any way, thus it will be necessary to wait for them to be finished in order for the termination to proceed.

ELEVENTH. –The parties manifest that the present agreement is a product of both institutions' good will, thus the head of each one states their commitment to perform all of the activities hereby exposed for achieving the expected results. In case of a controversy, the parties agree to solve it in common agreement and in a friendly manner without the need of any legal instances.
