SPECIFIC AGREEMENT OF COLLABORATION

BY THE UNIVERSIDAD AUTÓNOMA DEL ESTADO DE HIDALGO

AND

CHITKARA UNIVERSITY, INDIA



SPECIFIC AGREEMENT OF COLLABORATION BETWEEN THE AUTONOMOUS UNIVERSITY OF THE STATE OF HIDALGO, HEREINAFTER BE CALLED "THE UAEH" AND WHO SHALL BE REPRESENTED BY ITS RECTOR, HUMBERTO AUGUSTO VERAS GODOY AND ASSISTED BY THE SECRETARY GENERAL MTRO. ADOLFO PONTIGO LOYOLA, AND THE CHITKARA UNIVERSITY WHO WILL HEREINAFTER BE CALLED "CHITKARA" REPRESENTED BY BRIG (Dr) RAJWANT SINGH GREWAL, IN HIS CAPACITY AS VICE CHANCELLOR IN ACCORDANCE WITH THE FOLLOWING STATEMENTS AND TERMS:

ANTECEDENTS

1. That on May 30, 2012 the signing parties celebrated a General Agreement on Academic Collaboration with the objective of students and faculty exchange programmes.
2. According to the General Agreement on Academic Collaboration which establishes the basis for the celebration of specific agreements, the parties involved agree to sign the present instrument.
3. In accordance to the General Agreement on Academic Collaboration the institutional representatives have agreed the actions that will derive from this instrument

OBJECTIVE

The present Agreement aims to establish a student exchange program from different academic areas with the objective of providing participating students the opportunity of taking an academic term abroad.

COMMITMENTS FROM BOTH PARTIES

For the correct operation of this Agreement, the signing parties commit themselves to:

CLAUSES

FIRST. – Both institutions agree to admit a specific number of incoming exchange students who have completed at least a third part of their academic program in their home university.



SECOND. – Students must matriculate themselves in their home institutions as regular students.

THIRD. – The host institution will not charge the incoming exchange student any kind of fee.

FOURTH. – All of the expenses related to transportation, accommodation, food, medical insurance and of any other kind are the sole responsibilities of the exchange student.

FIFTH. – The exchange student will be provided with access to library and network services and to sporting facilities at the host institution.

SIXTH.- The selection process of exchange students is the home institution's responsibility. According to this, the home university must inform the host university, with at least three months before the beginning of the academic term, the names of the selected students.

SEVENTH. – The subjects and/or credits that the student passes and/or obtains will be recognized and validated by the home institution.

EIGHTH. – For the correct implementation of the program, the executing units identify themselves as follows:

On behalf of Chitkara, Prof Sangeet Jaura, Associate Vice President and on behalf of UAEH, Mr. Rafael Cravioto Torres, Director of the Office of International Relations.

NINTH. – This protocol will have a validity of five years, after which the experience will be evaluated and thus this agreement can be renewed with the mutual consent of both the parties.

TENTH.- This agreement can be terminated by initiative of any of the parties. However, the termination initiative should be submitted by written means with at least 90 (ninety) days prior to the termination date. In the event that there were activities still being performed and not yet concluded, they will not be affected in any way, thus it will be necessary to wait for them to be finished in order for the termination to proceed.

ELEVENTH.-. The financial conditions will be agreed by the parties for each specific collaboration agreement. These conditions must be submitted by written means and signed by both parties



TWELFTH.- The parties agree that during the validity period of this agreement, it is permitted to incorporate modifications to it, and if applicable, to the specific ones to be celebrated in the future, whenever there exists a written and signed modification proposal agreed by both parties.

THIRTEENTH.- The parties manifest that the present agreement is a product of both institutions' good will, thus the head of each one states their commitment to perform all of the activities hereby outlined for achieving the expected results. In case of a controversy, the parties agree to solve it through mutual consultations and in a friendly manner without the need of any legal assistance.

After the present specific agreement of collaboration has been read and both parties informed of its content, scope and legal purposes of each and every one of its clauses, those involved in this agreement, sign at the bottom and margins in duplicate, on the 30th day of the month of May, two thousand twelve.
