SPECIFIC AGREEMENT OF COLLABORATION BETWEEN THE AUTONOMOUS UNIVERSITY OF THE STATE OF HIDALGO, HEREINAFTER BE CALLED "THE UAEH" AND WHO SHALL BE REPRESENTED BY ITS RECTOR, HUMBERTO AUGUSTO VERAS GODOY, AND THE SHIH CHIEN UNIVERSITY WHO WILL BE CALLED HEREINAFTER "USC" REPRESENTED BY Michael J.K. Chen , IN HIS CAPACITY AS PRESIDENT, IN ACCORDANCE WITH THE FOLLOWING STATEMENTS AND TERMS:

## STATEMENTS

### 1. - Of "The UAEH"

1.1 It is a public decentralized and autonomous organism, provided with the capacity and its own legal status, in accordance with its fundamental law valid from May 4, 1977, and its last reform on June 7, 2010, whose aims are:

- To organize, impart and promote senior high school, middle school, professional and postgraduate education, as well as flexible exit processes in every educational level.
- To promote and direct scientific, humanistic and technological research in a manner that responds to the needs of the integral development of the institution and of the country
- To spread in every sense, culture with a high social purpose.

1.2 That its legal representative is its Rector Humberto Augusto Veras Godoy according to articles 19 and 22, section XI, of its current Fundamental Law and 46, section V of the General Statutes of this educational institution. The aforementioned legal status grants him the authority to perform legal acts for the proper operation of the University.

13. The Secretary General, Adolfo Pontigo Loyola, by the powers vested in the article 70, section IX of the General Statutes, has the authority to endorse with his signature the legal functions performed by the Rector in the name of "The UAEH".

14. For the purposes of signing the present Agreement is necessary to mention its legal address, located on 600 Mariano Abasolo Street, Colonia Centro, Pachuca de Soto, Hidalgo, México; CP 42000.

15. Its Federal Taxpayer's registry number is UAE 610303-799.

### II.- Of the "USC":

II.1 SHIH CHIEN UNIVERSITY is a corporation legally formed under the federal law.

Michael J.K. Chen is USC's legal representative, and he is duly authorized to execute

II.2 This IAC on behalf of USC, as evidenced by the Ministry of Education (Taiwan, R.O.C).

II.3 USC has its address in: No.70 Dazhi Street, Zhongshan District, Taipei City, Taiwan (R.O.C).

## OBJECTIVE

The object of the present Agreement is to establish the specific bases and to join efforts in order to carry out together activities in research, teaching, academic collaboration and professional development; in the interest of both parties under the terms of the vestment of powers that were conferred by the laws that govern them and through specific programs.

## COMMITMENTS FROM BOTH PARTS

For the correct operation of this Agreement, the signing parties commit themselves to:

## CLAUSES

FIRST. – Both institutions agree to admit “3” incoming exchange students that have completed at least a third part of their academic program in their home university.

SECOND. – That students must matriculate themselves in their home institutions as regular students.

THIRD. – The host institution will not charge any kind of fee to the incoming exchange student.

FOURTH. – All of the expenses related to transportation, accommodation, food, medical insurance and of any other kind are responsibility only of the exchange student.

FIFTH. – The exchange student will be provided with the access to library, network services and the sports places in the host institution.

SIXTH.- The selection process of exchange students is home institution's responsibility. According to this, the home university must inform to the host one, at least with three months before the beginning of the academic school year, the names of the selected students.

SEVENTH. – The subjects and/or credits that the student obtains will be recognized and validated by the home institution.

EIGHTH. – For the correct implementation of the program, the executing units identify themselves as:

Dr. Tony Shou-Wang KUO, Dean of the International Affairs Office and Mr. Rafael Cravioto Torres, Director of the International Relations Office.

NINTH. – This protocol will have a validity of (3) three years, after which the experience will be evaluated and this agreement can be renewed if both parties consider it necessary.

TENTH.- This agreement can be terminated by initiative of any of the parties. However, the termination initiative should be given by writing with at least 90 (ninety) days before the termination date. In the event that there were activities still being performed and not yet concluded, it will not be affected in any way, so it will be necessary to wait until it be finished in order to proceed the termination initiative.

ELEVENTH.- The financial conditions will be agreed by the parties for each specific collaboration agreement. These conditions must be given in writing and signed by both parties.

TWELFTH.- The parties agree that during the validity period of this agreement, it is possible to make modifications to it, and if applicable, to the specific ones to be celebrated in the future, whenever there exists a written and signed modification proposal agreed by both parties.

THIRTEENTH.- The parties agree that in relation to copyrights, patent rights, inventions certifications, registrations of models and industrial drawings, etc., each specific agreement of collaboration will stipulate what is necessary to regulate the issues related to copyrights and the ownership of the materials elaborated from the work and research as a result of the joint activities of the parties.

FOURTEENTH. The parties manifest that the present agreement is a product of the goodwill of both institutions, thus the head of each one states their commitment to perform all of the activities hereby exposed for achieving the expected results. In case of a controversy, the parties agree to solve it in common agreement and in a friendly manner without the need of any legal instances.

After the present specific agreement of collaboration has been read and both parties have been informed of its content, scope and legal purposes of each and every one of its clauses, that are involved in this agreement, they sign at the bottom and margins in duplicate, on the 10th day of the month of March, two thousand fifteen.
