SPECIFIC AGREEMENT OF COLLABORATION BETWEEN THE AUTONOMOUS UNIVERSITY OF THE STATE OF HIDALGO, HEREINAFTER BE CALLED "THE UAEH" AND WHO SHALL BE REPRESENTED BY ITS RECTOR, HUMBERTO AUGUSTO VERAS GODOY AND ASSISTED BY THE SECRETARY GENERAL MTRO. ADOLFO PONTIGO LOYOLA, AND THE TOMAS BATA UNIVERSITY IN ZLÍN WHO WILL HEREINAFTER BE CALLED "TBU" REPRESENTED BY Prof. Ing. PETR SÁHA, CSc., IN HIS CAPACITY AS RECTOR IN ACCORDANCE WITH THE FOLLOWING STATEMENTS AND TERMS:

## STATEMENTS

### I. - Of "The UAEH"

1.1 It is a public decentralized and autonomous organism, provided with the capacity and its own legal status, in accordance with its fundamental law valid from May 4, 1977, and its last reform on June 7, 2010, whose aims are:

- To organize, impart and promote senior high school, middle school, professional and postgraduate education, as well as flexible exit processes in every educational level.
- To promote and direct scientific, humanistic and technological research in a manner that responds to the needs of the integral development of the institution and of the country
- To spread culture in every sense with a high social purpose.

1.2 That its legal representative is its Rector Humberto Augusto Veras Godoy according to articles 19 and 22, section XI, of its Fundamental Law in force and 46, section V of the General Statutes of this educational institution. The aforementioned legal status grants him the authority to perform legal acts for the proper operation of the University.

13. The Secretary General, Adolfo Pontigo Loyola, by the powers vested in him under article 70, section IX of the General Statutes, has the authority to endorse with his signature the legal functions performed by the Rector in the name of "The UAEH".

14. For the purposes the signing of the present Agreement is deemed necessary, the legal address is located on 600 Mariano Abasolo Street, Colonia Centro, Pachuca de Soto, Hidalgo, México; CP 42000.

15. Its Federal Taxpayer's registry number is UAE 610303-799.

### II.- Of the "TBU":

II.1 That it is a public higher education institution.

II.2 That it has as its objective provide education, research and other activities in the field of higher education.

II.3 That he, prof. Ing. Petr Sába, CSc., as Rector of TBU, has the authority to sign the present document, as the statutory representative of TBU.

## **OBJECTIVE**

The object of the present Agreement is to establish the specific foundations for the process of academic exchange of students and to unite efforts in order to carry out joint activities in research, teaching, academic collaboration and professional development; in the interests of both parties under the terms of the vestment of powers that they were conferred by the laws that govern them and by means of specific programs.

## **COMMITMENTS FROM BOTH PARTIES**

For the correct operation of this Agreement, the signing parties commit themselves to:

## **CLAUSES**

Both institutions agree to admit "4 students /academic year" incoming exchange students that have completed at least a third part of their academic program in their home university.

Students must matriculate themselves in their home institutions as regular students.

The host institution will not charge the incoming exchange student any kind of fee.

All of the expenses related to transportation, accommodation, food, medical insurance and of any other kind are the sole responsibilities of the exchange student.

The exchange student will be provided with access to library and network services and to sporting facilities at the host institution.

The selection process of exchange students is the home institution's responsibility. According to this, the home university must inform the host one, with at least three months before the beginning of the academic term, the names of the selected students.

The subjects and/or credits that the student passes and/or obtains will be recognized and validated by the home institution.

For the correct implementation of the program, the executing units identify themselves as follows:

On behalf Jana Školoudíková, Head of International Relations Office and Mr. Rafael Cravioto Torres, Director of the Office of International Relations.

This agreement will have a validity of (5) five years, after which the experience will be evaluated and thus this agreement can be renewed if both parties consider it to be necessary.

This agreement can be terminated by initiative of any of the parties. However, the termination initiative should be submitted by written means with at least 90 (ninety) days prior to the termination date. In the event that there were activities still being performed and not yet concluded, they will not be affected in any way, thus it will be necessary to wait for them to be finished in order for the termination to proceed.

The financial conditions will be agreed by the parties for each specific collaboration agreement. These conditions must be submitted by written means and signed by both parties

Alterations and improvements to the Agreement can only be made in the form of amendments in writing, which are to be explicitly marked as amendments to the Agreement and signed by the authorized representatives of both contracting parties.

The parties agree that in relation to copyrights, patent rights, inventions certifications, registrations of models and industrial drawings, etc., each of the specific agreements of collaboration referred to in the third clause, will stipulate what is necessary to regulate the issues related to copyrights ownership and the materials elaborated from the work and research as a result of the joint activities of the parties.

The parties manifest that the present agreement is a product of both institutions' good will, thus the head of each one states their commitment to perform all of the activities hereby exposed for achieving the expected results. In case of a controversy, the parties agree to solve it in common agreement and in a friendly manner without the need of any legal instances.

After the present specific agreement of collaboration has been read and both parties informed of its content, scope and legal purposes of each and every one of its clauses, those involved in this agreement, sign at the bottom and margins in duplicate, on the 23th day of the month of October, two thousand *fourteen*.
