ARTICLE I

The agreement between the parties involves collaboration between the **UNIVERSITY OF PARDUBICE** and the **UNIVERSIDAD AUTÓNOMA DEL ESTADO DE HIDALGO** in related disciplines.

The two institutions shall seek to promote:

1. staff exchange in programmes for the mutual benefit of both institutions.
2. student exchange in study programmes for the mutual benefit of both institutions.
3. collaboration in teaching, research and development, and consulting activities
4. exchange of academic materials and publications.
5. provision of opportunities for cultural and intellectual enrichment of the staff and students of both parties.

ARTICLE II

The activities under this linkage will include:

1. Staff Exchanges

Staff exchange activities cover visits to either institution for any of the following purposes:

- (i) undertaking joint research;
- (ii) attachment of staff for the purposes of curriculum development and review, attendance in courses and the upgrading of teaching and research skills;
- (iii) participation in seminars, colloquia and other types of academic discussions;
- (iv) contributions to teaching programmes;
- (v) co-supervision of post-graduate students;
- (vi) study tours and joint consultancy.

2. Student Exchange

Student exchange activities (e.g. undergraduate, graduate and doctoral students) cover visits to either institution for any of the following purposes:

- (i) participation in research;
- (ii) undertaking courses;
- (iii) involvement in activities organized for international students.



3. Exchange of Academic Materials

Exchange of relevant academic materials will be carried out subject to the mutual agreement of the parties

ARTICLE III

The implementation of cooperation based on this Memorandum shall be dealt with between the relevant faculties and departments of both institutions. Where necessary, a specific plan shall be worked out for each activity setting forth detailed arrangements for collaboration. Such plans shall be subject to the approval of the appropriate authorities of each institution. To facilitate the development of such plans, each institution shall nominate a senior member of its staff to coordinate activities arising under this agreement.

Such plans will be described in the annexes to this Memorandum of Understanding and should be the responsibility of the faculty concerned.

ARTICLE IV

Both institutions agree and undertake to keep confidential at all times any information and/or data that may be exchanged, acquired and/or shared in connection with the area of cooperation as mentioned in ARTICLE I (3) unless the same information already exists in the public domain.

ARTICLE V

Ownership of any joint research findings shall be guaranteed by both parties to this Memorandum and any publications regarding the same shall only be possible upon prior approval of both parties.

ARTICLE VI

The Memorandum shall remain in force for a period of 5 years commencing from the date of signing and may be renewed by a 3-month written notice to the other party. Upon renewal, both parties shall choose to extend the existing period or to agree on new terms and conditions.

ARTICLE VII

Both the University of Pardubice and the Universidad Autónoma del Estado de Hidalgo reserve the right to terminate this Memorandum by either party giving 3 months written notice to the other party. Where such termination occurs, the provisions of this Memorandum shall continue to apply to ongoing activities until their completion.



ARTICLE VIII

Participating staff and students involved in any activities under this Memorandum must adhere to the law of the host countries and the rules and regulations of the host institutions.

ARTICLE IX

The University of Pardubice and the Universidad Autónoma del Estado de Hidalgo welcome the establishment of this Memorandum for cooperation and jointly agree to the provisions as set out above. The Parties have signed this MoU in four (4) original copies of which each Party has received two copies: two in Spanish and two in English.

The parties sign it in duplicate in the city of Pachuca de Soto, Mexico, on the 03 day of junio 2025.
